PLAYER CONTRACT / WAIVER

Instructions:

3. Be sure you turn this form in to your manager completed with your signature on the Team Roster and Waiver form.
4. Be sure you read and print yourself a copy of the "MSBL/MABL Mohawk Valley League 2008 Rules and Regulations."

MSBL/MABL & MVL League Rules:

Alcoholic beverages are specifically prohibited on any of the premises we utilize. These are governed by a variety of municipal, state and private polices. Additionally, the Mohawk Valley League and the MSBL expressly prohibits any alcoholic beverages in the vicinity (including parking lots) of any field used by our participants so as to avoid any appearance of any of these policies having been violated. This applies to all manager, players, coaches as well as fans, friends, or family who come to our MVL games. Any manager or player(s) found to be in violation of these rules will be asked to leave the premises. They will also face disciplinary action against themselves and/or the team by the league President. Any special conditions set forth by any of the facilities utilized by the MOHAWK VALLEY LEAGUE will be followed.

AGREEMENT

I understand that I must be at least 18 years of age by June 1st of this calendar year and have a valid driver's license or photo ID at all times in order to prove my identity. I will be available to participate in the activities during the pre-designated times and dates as set forth in the MVL season schedule to include post season. If, in the event that uncontrollable circumstances causes the scheduling of the event to be altered, I will be able to accommodate the new schedule. I will abide by any new schedule changes so long as they fall within reason and that reasonable notice has been given. I will comply with all rules and regulations governing the MVL. I will be a participant in good standing free of any debt to the Mohawk Valley League, the team or manager whom I play for (Past or Present)
